RE: Termination Letter

Dear Mr. Bernstein:

In my capacity as Chief Executive Officer of Iviewit Holdings, Inc. and its subsidiaries, regretfully, I am terminating your association with Iviewit for **CAUSE**, effective immediately.

According to Section 3.2 of your Employment Agreement ("Agreement"), termination for **CAUSE** occurs in any of the following instances:

For all purposes under this Agreement and during the Term, **CAUSE** shall mean: (a) a willful failure by Executive to substantially perform his or her duties under this Agreement, other than a failure resulting from Executive's complete or partial incapacity due to physical or mental illness or impairment; (b) the commission or any act of fraud, gross negligence, or willful misconduct on the part of Executive; (c) misappropriation, embezzlement, theft, or willful and material damage to any asset of the Company or the use of the Company's funds or assets for any illegal purpose; or, (d) the conviction of Executive of any felony that materially and adversely, whether directly or indirectly, affects the name or goodwill of the Company [emphasis supplied].

Following along, your egregious actions:



1. For the knowing and willful theft of at least Four Hundred Thousand Dollars (\$400,000) in company monies, you are terminated for **CAUSE** according to 3.2.(c) of the Agreement;
2. For your motion in the Appeal in the United States Court or Appeals for the Second Circuit where you threatened Circuit Court Judges with criminal charges that caused the case to be summarily dismissed, you are terminated for **CAUSE** according to 3.2.(a) of the Agreement; and
3. For you knowing and willful frauding of the Iviewit corporate record in the recent post on a blog administered by Crystal C. Cox attributing a Senate Bill for cessation of “secret societies” among public officer to P. Stephen Lamont, you are terminated for **CAUSE** according to 3.2.(b) of the Agreement.

For all the above reasons, Mr. Bernstein, your association with Iviewit is terminated effectively immediately for **CAUSE**. Such termination for **CAUSE** results in the cancellation of all your capital shares in Iviewit (find Cap Table_Final_Version 11 attached with your children’s interests), Iviewit is released from all obligations to you with respect to the Agreement, and the obligation to cease and desist frauding the corporate record and preservation of such corporate record is yours completely (a nominal sum will be paid to you for warehousing such corporate record at a date and time to be determined).
